Questions Board member about paying property tax

Kendall County Board member John Purcell denied accusations made by a member of the public at Tuesday's County Board meeting suggesting that he has failed to pay real estate taxes on property he owns in Kendall County.

Purcell addressed the charges after the board meeting adjourned.

"It's not accurate, that's all I have to say to that," Purcell said.

Kendall County resident Todd Milliron presented the County Board with a list of parcels in Kendall County he claimed Purcell owned in Country Hills and Whitetail Ridge Subdivisions. He further claimed that Harmony Development Inc., a business in which Purcell is a full partner, owed about \$62,000 in taxes to the county.

"Mr. Purcell, as a citizen of this county I expect you to pay your taxes for your pin parcels," Milliron said.

"I'm expected to abide by the law and pay my property taxes to our county treasurer," Milliron said.

He maintained that one of the qualifications for seeking public office is to be current on property taxes and that Purcell should reconsider his intention to seek another term of office on the County Board.

"All my taxes are paid and I don't even own all the lots he is referring to," Purcell said.

He did acknowledge that he owns two lots in the Whitetail Ridge subdivision that Milliron was referring to with partners in Harmony Development, Inc.

"They are fair questions but it's not accurate information," Purcell said. "If he had complete accurate information, I could respond to what he said but it is hard for me to respond to something that is inaccurate. Like a lot of people, we have run into some financial troubles but we don't own all the lots."

Purcell added that he felt the accusations may be politically motivated.

"My personal taxes on my homes are all paid," Purcell said.

Candidate: Kendall board member's firm owes \$58,947 in back taxes

YORKVILLE — A Kendall County Board candidate continues to question whether another candidate's company has failed to pay property taxes on land in the county.

Todd Milliron, who was nominated last week by the Green Party, is claiming that a company in which current board member John Purcell is a partner in owes the county \$58,947 in back property taxes.

Purcell, a 1st District Board member, was nominated last week on the Republican ticket for re-election in November. He has an interest in Harmony Development Inc., which has

developed the Country Hills and Whitetail Ridge subdivisions.

Milliron claims property taxes are owed on 32 parcels in those subdivisions.

Milliron first raised his questions about the land in January, then again last week, before the County Board.

"As a citizen I am expected to pay my property taxes, and I expect no less from someone in such an important elected position on our County Board," Milliron wrote in a speech he gave to the board.

Purcell, of Oswego, has

not addressed Milliron's claims directly, although in January he denied that he has not paid taxes. He said the land in reference is part of a corporation that he is part of, but he does not own the land directly.

Milliron and Purcell are both candidates for two open seats in District 1 on the Kendall County Board in November. Milliron has run for unsuccessfully for the board in the past as a Republican, but ran as a write-in for the Green Party last week.

He appears to have gotten 12 votes, which should be enough to nominate him for one of the two Green Party spots on the slate. Terry Sampson was the Green Party high vote-getter with 24 votes.
